## The Job:

Assist the Quality Shift Supervisor in ensuring that all products are produced and filled to the customer-approved specification and to an acceptable quality. Working in conjunction with other members of the team, Filling and Production staff. Carrying out testing on bulk manufactured products. Ensuring the company's QC procedures and policies are being followed in all areas at all times.

## QC Technologist Job Duties:

- Carrying out line checks on filled finished products, checking packaging, labelling, batch coding, weights and general appearance are all correct.
- Carrying out testing of bulk manufactured products ensuring they meet specification. Seeking advice from chemists when needed.
- Carrying out inspections of components, labels and raw materials as required.
- Maintaining Quality Control records.
- Assisting the Quality Shift Supervisor to ensure a high level of quality control is maintained at all times and that all procedures are being adhered to.
- Undertaking QC checks and producing reports (daily, weekly, monthly, quarterly) for Hygiene in Production, Warehouse, Storage and Laboratory areas.
- Working with the Quality Shift Supervisor on Non-Conformance Reports and Quality systems – ISO9001, BRC & ISO22716 with the view of continuous improvements
- Record keeping.
- Calibration of pH meters and viscometers as required.
- Maintaining laboratory equipment.

We currently operate a weekly rotating shift pattern 05:45 – 14:45 and 13:00 to 22:00 Monday – Friday, 41.25 hours per week.
